The student attended an AZ public or charter school for at least 90 days, or a full semester, in the prior school year, and transferred to a private school.

The student is currently enrolled in Kindergarten.

The student is a dependent of a member of the US Armed Forces who is stationed in Arizona under military orders.

The student previously received a Corporate or Overflow/PLUS scholarship, and has attended private school continuously since.

The Arizona taxpayer *must first* donate the **\$1,110** (*married*) or **\$555** (*single*) maximum for the Original Tax Credit *in order to donate any additional amount* to the Overflow Tax Credit (up to another **\$1,103/\$552**, or your actual tax, whichever is less).
