Applications must be received or postmarked by the deadline to be included in each remaining award cycle for the '26-'27 school year. **This application will expire on May 31, 2027, regardless of when it is received.**

If your student is a dependent of a member of the U.S. Armed Forces stationed in Arizona pursuant to military orders, please attach a copy of those orders showing the location of the Arizona station.

## ESA STATUS

Empowerment Scholarship Accounts (ESAs) are an entirely separate tuition funding source from tax credit scholarships (i.e., ACSTO scholarships). ESAs are administered by the [Arizona Department of Education](#), **not by ACSTO**.

Per the ESA law, tax credit scholarships **cannot be sent** to the student's school while a parent has a signed ESA contract for the student. The parent must provide documentation from the Arizona Department of Education confirming that the student's ESA contract was closed or not renewed before any tax credit scholarships can be sent to the school.

Students with an ESA contract can still be considered for tax credit scholarship awards, but awards must be **held by ACSTO** in the student's name until documentation is received that the ESA was closed or not renewed. Awards are only held if the parent: 1) Submits an ACSTO application each school year and 2) The student remains continuously enrolled at an ACSTO Partner School.

If your student's ESA status changes at any time during the school year, please notify ACSTO immediately.
